SHIELD 6 AWNING

INSTALLATION INSTRUCTIONS

For best results use the channel nuts recommended by your roof rack manufacturer

① Check contents and separate items for install.



② Bolt the channel nuts to the brackets making sure to use both the flat and spring washers.



③ Slide the bracket into the roof rack channel.



④ Slide bracket into position and tighten.



⑤ Prepare the remaining 20mm long bolts and nyloc nuts for the next step.



⑥ Slide 1 bolt into the top and 1 into the bottom channels of the awning extrusion.



⑦ Roughly line up the bolts to where the awning brackets will be on the vehicle.



⑧ Align the awning bracket onto the bolts and apply a small amount of the grease to each bolt (this will prevent nuts from seizing).



- ⑨ Put the nyloc nuts onto each of the bolts, tighten slightly so the awning extrusion still slide. Slide the awning into position and tighten.



- ⑩ Regularly check that all bolts are tight and in good condition.



- ⑤ Unfold front swing arms and hook the first ratchet strap from the pull tab at the end of the front arm to the bull bar, roof rack or front wheel. Don't tighten yet!



- ⑥ Undo the velcro strap on the left side of the backing plate that is holding the back swing arms in place. Unfold back arms.



You're ready to go!

SETUP INSTRUCTIONS

- ① When selecting your site, make sure you have enough clearance on the side and rear of the vehicle for the awning to fold out.

- ② Unzip tonneau bag and fold the bag over the awning.



Top Tip! Prepare ratchet strap for tensioning, we store ours in the back bracket

- ③ Pay particular attention to folding the bag back from the hinge.



- ④ Undo all 4 velcro straps holding the canvas and aluminium arms. Don't worry if the awning arms start to swing, this is normal - they're self supporting!



- ⑦ Attach the ratchet strap to the eyelet pull tab at the end of the back swing arm.



- ⑧ Tighten the front ratchet strap.



Congratulations you're all done!

Time to crack open your favourite beverage, throw a footy, flick a line or just sit under your brilliant awning and admire the view.

The Shield 6 is designed for all but the most extreme weather, however for peace of mind in the event of sudden bad conditions, we recommend you attach and peg out the rain tabs. For added security our extreme weather kit (sold separately) can be used. This includes optional poles and screw pegs can also be used.

PACK AWAY INSTRUCTIONS

- ① Take tension off the rear ratchet strap by pulling gently on arm and unhook from awning.



- ② Collapse back arms against backing plate and secure with the velcro.



- ③ Unhook front ratchet strap from front swing arm and collapse arms against backing plate. Secure with the velcro.



Top Tip! Push the canvas up as you close the back arms to reduce rubbing and extend the life of your awning

- ④ Run your hands through the canvas folds to remove creases. Place one hand at the bottom of the canvas between the peaks of the folded front and back canvas. With the other hand, fold up the peaks of both front and back canvas, making a single triangle shape. This will align the velcro strips of both arms and reduce the pack up size.



- ⑤ Snugly roll the canvas until the bulk is sitting just above the bag line. Swing the canvas out and up and hold in line with the top of the folded awning.



- ⑥ Secure all 4 velcro straps around folded awning. Pull the bag over and zip up!

If the awning is packed up damp please be sure to put it up again in dry weather as soon as possible to dry the canvas out.

Any neglect or abuse of awning can result in voiding the warranty.

CARE INSTRUCTIONS

- 1

As this is a stitched canvas product, this awning will need to be seasoned. This involves wetting down the awning and letting it fully dry a few times to ensure no stitching leaks will occur.
- 2

If any leaks were to continue, a seam sealer/waterproofing agent can be applied to the stitched seams to further water proof these areas.
- 3

If the awning is packed up damp be sure to set up the awning as soon as weather permits in order to fully dry the canvas to prevent mold or mildew growing.
- 4

If any mold or mildew was to form on your awning this can be removed with clean water and a soft brush. Do not use any chemicals! The canvas is both rot and mildew resistant which means it will not embed into the canvas.



PRODUCT WARRANTY TERMS & CONDITIONS

- 1

PERIOD OF WARRANTY

In addition to any warranties or conditions implied by consumer law, we warrant this product against defective workmanship and faulty material under normal use for twenty-four (24) months from the date of purchase (the Warranty).

To the extent permitted by law and for the purposes of the Warranty where the product is found to be defective during the Warranty period, our sole obligation under the Warranty is, at our option, to repair or replace, free of charge, the product or part thereof on condition that the item or part in is:

1.1

Returned to us or to one of our Authorised distributors, freight pre-paid and found on our examination, to be suffering from a material or construction defect.

1.2

We cannot be held responsible for any repair other than those carried out by us or one of our authorised Service Agents.

PROOF OF PURCHASE

2.1

This product has been manufactured to the highest quality standards and is warranted to the original purchaser or gift recipient only. This Warranty is not transferable.

2.2

Please keep your purchase docket or receipt as proof of purchase and as proof of the date on which the purchase was made. The purchase docket or receipt must be presented when making a claim under this warranty. If in the event the receipt of purchase is not presented, or cannot be satisfied by other means, satisfactory to us, then this warranty is invalid.

SERVICE OR REPLACEMENT DURING THE WARRANTY PERIOD

3.1

In the event that this product is Dead on Arrival, the owner has 14 days in which to return the product to the retailer or the place of purchase for a new replacement. If the owner does not return the product within 14 days then the product will be treated under normal warranty conditions.

3.2

Please ensure that the product is properly packaged so as to ensure that no damage occurs during transit. Full details should also be provided as to the nature of the issue.

3.3

For items requiring repair under warranty, the owner is responsible for the cost of transportation back to the place where the product was purchased. Whilst in transit the goods are at the owner's risk.

4.1

4.2

4.3

This warranty does not cover any defect caused by an accident, misuse, abuse, improper installation (by retailer or any other third party) or operation, lack of reasonable care, loss of parts, tampering or attempted repair by a person not authorised by the manufacturer.

4.4

This warranty does not cover damage to the product or property, for the item not secured down properly, using the incorrect anchoring devices for the ground surface, act of God or use in unfavourable conditions.
